Our goal is to help you and your business train and retain your workforce.

PROGRAM COMPONENTS

Eligibility: Open to businesses served by WVPA member electric distribution co-ops.

Funding Structure: Reimbursement up to \$1,000 per employee or \$15,000 per business. The grant can reimburse for trainees/trainers wages.
